Dear Christ Lutheran members and friends, Another year has passed, and so much has happened in the year 2023 for me, Cynthia, my daughters (Lexi, Lauren, and Lacey), and our church here at Christ Lutheran!

Back in September of 2022, I was finishing up my last class at Wartburg Seminary in Dubuque, lowa after nearly nine years of taking classes, when I

started filling out the Roster Ministry

Profile to possibly look for a full-time pastoral

position. I have been a part-time pastor for the last nine years in Iowa (St. Paul's in Lakota,

lowa, and Immanuel's in George, Iowa) along with being a full-time teacher. I completed this and prayed God would lead Cynthia and me on the right path of either continuing where I was

or becoming a full-time pastor somewhere in southwest Minnesota.

In January and February, I started looking at the ELCA vacancy website and did not see Christ

Lutheran Church on it, but then in late February, I

received a call from Pastor Heather from the

Southwest Minnesota Synod about the opening here. She asked me if I would be interested in an interview. I spoke with Cynthia and my daughters about this amazing opportunity and Cynthia told me she always listened to the services on KJOE 106.1 and told me to accept the invitation for the interview.

I was nervous as I had never gone through a formal interview like this at my two previous smaller country churches. I was blessed to receive the questions ahead of time which made me more prepared and relaxed. The initial interview went well I thought and was then later allowed to come to the church for a second interview. This was great, yet there was an ice storm that hit the night prior that made the roads not very good, Cynthia and I slowly drove to Slayton and were grateful for how kind everyone was and you even fed us! I would accept the position a while later and we would be moving to Slayton in the late spring or early summer months as Cynthia and I would be getting married on August 5th!

Cynthia and I felt welcomed right away into the church as we slowly learned about the members and friends of Christ along with the community! I would become ordained on June 25th with Cynthia, my girls, and other family members by my side. This was a glorious experience for both Cynthia and me as I heard the last time our church had an

ordination was in the late 1960s!?! Since then, now seven months later 'WE' as a 'Family of God' have done a lot of great work together. This reminds me of the Bible verse from John 14:12 - **12** Very truly I tell you, whoever believes in me will do the works I have been doing, and they will do even greater things than these because I am going to the Father. We certainly have!

I remember there was a survey that was filled out and I studied that after I became your pastor and tried diligently to work on those items. There were three items you were all focused on that I prayerfully have been excelling at this with all your help! They were (1) Leadership for the Worship Service, (2) Visitations, and (3) Working with the Youth.

(1) Leadership for the Worship Service

I humbly accepted this task with your help to raise up our church in 2023. Here's a summary:

Our church has been doing fairly well, yet like every church, we still can improve and become an even more welcoming church than we already are. As the front of our bulletin says, 'We will seek God's will, share God's love, and serve as Christ's people.'

Here is the average attendance from 2019 to 2023:

2023 - 91 avg.	2022 - 80 avg.
2021 - 57 avg.	2019 - 97 avg.

Can we be such a welcoming church that in 2024 we average 100 people each Sunday and have new members and friends join us? One member had a Facebook post about a way to grow the church by having the members invite others to the church. This is a team approach to expanding God's kingdom and it begins with each of us becoming the best disciples we can for Jesus Christ!

(2) Visitations

I have been honored and thankful for the opportunity to try and meet with every one of you through a house visit, and your coming to the church along with phone calls, texting, and emails. I have met with nearly 100 members and friends and will continue doing this throughout my ministry. We now have yellow cards in each of the pews for you to fill out if you want me to visit with you. Now - I ask you to do the same and visit those shut-ins and giving communion, nursing homes, and those who are going through some challenging times like surgery, loss of a job, a divorce, and/ or death in a family.

(3) Working with the Youth & Bible Studies

We are blessed as a church to have so many volunteers to help our youth and those teaching a variety of Bible studies to our adults. I am amazed at how our youth are getting more involved and the engaging studies we have taught this year. May 'WE' continue working together as a 'Family of God' here at Christ Lutheran Church and seeing God's church grow throughout our communities!

With every new year, people have new dreams and goals for themselves and their loved ones, a church is the same - we also have goals and dreams to make the church of Christ Lutheran the most effective it can be for God's people.

1 Corinthians 12:14 says, "For the body is not just one member, but of many." In essence, this is the simplest and clearest statement about teamwork in the Bible. The body of Christ, or the people that are the whole of humanity, are a team. The body is not supported by one person but by all of us. We are one, we are strongest working together in unity. Teamwork is the key to living life in harmony so that we can do God's will.

So I have just one request I would like to ask you, "What talents, what gifts do you have that can make Christ Lutheran the most effective for ALL of God's people for this 2024 year?"

Please ponder these two questions in your heart -

(1) What has gone well here at Christ Lutheran in 2023?

(2) What do we need to work on to make our church more welcoming to others in our communities in 2024?

November 8, 2023

The meeting was called to order by President Sue Blackmer.

Pastor led us with devotions taken from Philippians.

The Secretary's report for October 11, 2023 was reviewed. M/S/P Trish and Lorna to accept as presented.

The Treasurer's report was reviewed. Our October balance is \$48.976.68. Gail encouraged CLC to develop a reserve/savings account to cover unexpected expenses in times of hardship. The October treasurer's report will be filed for audit.

President Blackmer stated that our Committee and Board ministry descriptions do not match up with our Constitution language. A reminder was given again, to all committees to prepare their annual reports soon and to review their ministry descriptions.

Pastor Duffy reported that the cleanup day, trunk and treat event and All Saints service were a success. Our average October attendance was 97. There is a new Sunday Bible Study scheduled. The Sunday School Christmas Program will be December 17th.

New Business

1. Hospice use of the Fellowship Hall on 11-14-23. An earlier an email vote was taken and therefore a motion was made, seconded, and passed to ratify this motion by Jeff and Kathy W. The motion included to waive any charges.

2. Nikki Cheskie use of facility. The request was made to use a locked room and the chapel lounge for her Helping Hands Christmas Gift Project. Due to the expansion of the Sunday school room's usage, we cannot offer a locked room for her use. Therefore a motion was made to allow her the use the fellowship lounge on Friday afternoon for storage and for her distribution on Saturday, with fees being waivered. The Church would be locked Friday night. M/S/P Trish and Karen F.

3. Mailing Newsletter/service project. USPS announced they will no longer be offering bulk mail services as of January 28, 2024. We will encourage email delivery, copies printed for pick up and possibly a service project for students for other deliveries.

4. Cap on spending. M/S/P Jeff and Gail For committees and boards, any expense over the amount of \$150.00 must be approved by the council, prior to a purchase, with a

description provided of the expenditure.

5. Letter to board and committee members. The council has the legal obligation to enforce our constitution. Non budgeted expenditures need the approval in written minutes of the board or committee making any request. This request shall then be presented to the council for approval. A copy of this action will be submitted. A motion was made to assign the council to approve and sign this action, M/S/P Trish and Jeff

6. Constitution. This process is almost complete with the committee, pending final review from the synod consultant. It is our hope that all the requirements can be completed to allow us to vote at our Annual meeting in January. This is now tabled until the final review is completed, at which time a special council meeting will be held, to expedite the process. M/S/P Trish and Gail

7. Shetek Lutheran Ministries request for money. The Director has sent correspondence to request \$2.00 for every baptized member (855) of Christ Lutheran. Discussion was held regarding the synod involvement of the camp. Is Shetek Lutheran Ministries still considered to be and ELCA sponsored camp? This request for funding was tabled. M/S/P Gail and Trish

Topics Discussed

Fall Clean-up was held on October 21st. In addition to Property & Management board members helpers included Floyd Radke, Sue Davis, Sue Gass, & Tom Kappes (sorry if I missed anyone). Leaves & branches were cleaned up & Trees on the north side of the property were

trimmed.

Slayton Plumbing & Heating has finally initiated work in the quilt room including relocating heat registers. Slayton Electric will be installing / relocating electrical outlets.

Jeff will put warning paint on a hazard / hole in the sidewalk on the west side of the building. That sidewalk panel and 3 panels in the parking lot that have damage from salt will be replaced next summer.

Trees at the parsonage need to be trimmed. Since special equipment will be required Jeff will contact Peschges Tree Service for an estimate.



Regular Council Meeting November 8, 2023 7:00 PM The Executive Council and Pastor Chad, under the advisement of the Synod office, would like to share the following information to all members of Christ Lutheran Boards and Committees.

Christ Lutheran is a non profit organization. In the state of Minnesota, the council, as governing board, has the legal obligation to enforce the constitution.

In the future any unexpected, non-budgeted expenditures need to be approved in the written minutes of the board or committee making the request. The written request must then be presented and approved by the council.

The charges for the unauthorized sign recently purchased will be considered an oversight and exception will be made, but going forward, we will follow the process established in the previous paragraph.



Monthly Newsletter Mailings

The post office will be discontinuing bulk mail rates as of January 28th. This affects the mailing of our newsletter. We will mail the January newsletter out, but that will be the last one received to your home.

Newsletters will be printed and available to be picked up at the church. Or an email copy can be sent to you.

If you are not currently receiving the newsletter in an email and would like to. Please provide the office with your email address.

If you are unable to pick up a copy and do not have email contact the Pastor.

Charitable Giving Reminder

If you are 72 or older you may be required to take out a minimum amount of your individual Retirement Account (IRA). The amount you may be required to take is called a Required Minimum Distribution (RMD). If the RMD is transferred directly to a charity (such as Christ Lutheran Church) your taxable income could be positively impacted. The direct transfer will keep your taxable amount lower while allowing you to support your chosen charity. It is recommended to contact your financial advisor or tax advisor for details on the RMD.

From your Parish Nurse....

January is National Birth Defects Awareness Month Birth defects are structural changes that can affect almost any part of the body, such as the heart, brain, or foot, and can cause lifelong health challenges. Birth defects are common, affecting 1 in every 33 babies born in the United States each year. Not all birth defects can be prevented, and they can occur in any family, regardless of race, ethnicity, health history, or economic status.

The National Birth Defects Prevention Network (NBDPN) raises awareness of birth defects and promotes strategies that reduce the risk of birth defects and their complications. National Birth Defects Awareness Month is a time to raise awareness about birth defects and highlight efforts to improve the health of people living with these conditions across their lifespan. As early identification, medical care and treatment have improved, babies and children with birth defects are living longer and healthier lives.

That is why MBDPN's 2024 theme is "Every Journey Matters", highlighting that from prior to diagnosis, throughout childhood and adulthood, every individual impacted by birth defects matters.

This January, take time to learn about:

*Birth defect prevention before and during pregnancy *Survival and health of infants with birth defects *Educational needs and special healthcare needs for children with birth defects

*Transition from pediatric to adult medical care for adolescents

*Planning for pregnancy, recurrence prevention, and genetics and family history for adults with birth defects NBDPN encourages all pregnant people and prospective parents to make healthy choices and adopt healthier habits to help lower their risk of having a baby born with a birth defect.

5 Healthy Pregnancy Tips:

Tip 1: Be sure to take 400 micrograms(mcg) of folic acid every day at least one month prior to conception.

Tip 2: Plan a visit with your health care provider to support a healthy pregnancy.

Tip 3 Reduce your risk of infections.

Tip 4: Care for your body and mind before and during pregnancy to set you and your baby up for success.

Tip 5: Avoid harmful substance during pregnancy, such as alcohol, tobacco, and other drugs.

WCLC Council Report November 8, 2023

The WCLC Board met on Tuesday, November 7th, 2023.

The Balance on Hand as of October 31st, 2023 in the Treasury is \$3,009.75.

Reports from Committees were given and placed on file. **Notes**:

1.Quilting room renovation continues. Quilters have raised a total \$2,960.82 in fundraisers towards this project. (1st Quilt Silent Auction netted \$653.00 and the 2nd Quilt Silent Auction is in progress). A grant of \$350.00 from Nobles County Coop's "Operation Round-up Program" is pending (November 16th) toward the quilt room renovations

- 2. The 2023 Trunk or Treat Event was a huge success again. It was the agreed that this event is a great asset to our community and church and we would like to see it continue. Cathy Blair wants to step down as organizer of this event. In order for this event to continue next year, perhaps a combined effort of CLC Council Mission Outreach Committee, the Mission Community Committee from the WCLC Board, and the Fellowship and Service Committee from Council could form a sub-committee to meet in September to work together with the office secretary to keep the Trunk or Treat Event going. We would like the Council to take action to affirm a commitment to this annual event.
- **3.** The Thank Offering Service is planned for Sunday, November 12th. The Mission Growth Committee has coordinated this worship service and installation of 2024 WCLC officers will be included.
- **4**.Cindi Pavlis was appointed to serve on the 2024 Mission Growth Committee.
- **5**. The WCLC Handbook for 2024 is completed, proofed, and ready for printing. The phone numbers of the women have been updated to reflect cell phone numbers and land line numbers where appropriate.
- **6**. The All-Women's Christmas Potluck even is tentatively set for Wednesday, December 13th at noon. Lila Anderson is working on getting a speaker for this event. Trays of Christmas Goodies (donated by the women) will be assembled after the Potluck Dinner for Sunrise Terrace, Lindenwood Assisted Living, and Westside Apartments.
- **7.** Quilting Dates are Monday November 27th and Tuesday November 28th at 1:00 pm.






